• 12 participants (ages 14 through 17) will be included. Rocky Mountain Flycasters will rely on each applicant's self-descriptive, one-page memo to help us better understand the youth's outdoors interests, experiences, commitment, and expectations from camp attendance to make application acceptance decisions. Because the camp is designed primarily to develop beginning level fly anglers, it is not expected or required that your youth already knows how to fly fish to be accepted. Some previous experience is not a disqualifier.

• If a camper is accepted into the 2024 NoCO Youth Fly Fishing Day Camp, and develops a significant physical, health or behavioral impairment before start of or during camp, the parent or guardian must inform the Day Camp Director as soon as possible at <u>youthcamp@RMFTU.org</u>. Depending upon the circumstances, the camper may be required to limit or cease participation, or a qualified caretaker may be required to be provided to assist the student. As Rocky Mountain Flycasters has a limited number of available adult participants, we retain the right to limit, alter, or rescind Day Camp participation if circumstance warrant.

• The 2024 NoCO Youth Fly Fishing Day Camp is conducted on five consecutive days, Monday-Friday, July 15th-July 19th. Sessions begin promptly at 8:00AM and most end at 6:00PM daily, unless noted in red font on the Daily Schedule. On-time arrival a few minutes early each morning is important to ensure sessions begin, and transportation departs on schedule for field activities.

• Campers are expected to attend all five of the day sessions. Our curriculum builds sequentially upon previous days and absences can detract from effective learning by your camper and others. Parent or guardian is to inform the Camp Director in advance <a href="mailto:youthcamp@RMFTU.org">youthcamp@RMFTU.org</a> of unexpected illness or extenuating circumstances.

• Applications are not accepted until April 1, 2024 and will be reviewed until all slots are filled. Campers will usually be notified in approximately 30 days about their acceptance. In the event of non-acceptance, your \$50 Application Fee provided at the time of application will be returned.

• A current Daily Schedule is included in this Application packet. It may be updated before the start of our Day Camp and a final schedule may be emailed to you about two weeks before camp begins. The schedule answers many of your questions about what Campers will be studying, what outdoor activities they will be doing, and times and locations of all Day Camp activities. Any questions can be directed to the Day Camp Director by email using the contact information at the bottom of this Parent/Guardian's Information Form.

• Parents/Guardians are responsible for providing transportation of the campers to and from delivery and pickup locations described on the final Daily Schedule. We have arranged for van transportation to and from class and field activities together as a full group. The Daily Schedule describes specific locations for morning arrival and evening pickup. Campers who drive themselves to/from camp are required to ride the provided van to/ from activities. Campers are covered by Trout Unlimited group insurance and also van rental insurances.

• Indoor classroom sessions are conducted at identified local area public meeting rooms, and field activities will be conducted at identified stretches of the Poudre River, Fort Collins Natural Areas or Parks, and Rocky Mountain National Park.

# • Campers who are age 16 are required by law to have a Colorado fishing license on their person when fishing.

• **Parents/Guardians are invited to visit and observe** any of the Day Camp activities and classes. A liability waiver may be required, and some settings may not have enough space to accommodate observers comfortably or safely. You may check with the Camp Directors if you have interest in visiting and observing any of the sessions. Parent/Guardians who are experienced fly fisherman may be allowed to assist activities.

• Campers are required to bring their lunch each day. Food storage coolers and chilled water will be provided.

• Fishing equipment & supplies will be provided by Rocky Mountain Flycasters. Campers may optionally <u>request</u> to use their own rod/reel and other equipment. Personal equipment will be inspected in advance to ensure if it is acceptable, as we have occasionally observed that a camper's equipment may be detrimental to his/ her learning experience. Appropriate wading gear will be provided and options will be discussed.

• This is a unique and exciting experience for all participants and **Parents/Guardians are urged to talk with** their camper each evening about his/her day to better understand and encourage your camper's experiences.

• Campers may receive written material or electronic media with information that supports instructions and class content. They are expected to keep track of this material and review as necessary. Campers will be provided with fly tying tools and supplies. Any flies tied during classes will become the property of the Camper.

• On all outdoor activity days campers are required to bring and wear a hat (with Brim), long pants, long-sleeve shirt and closed toe shoes. As weather and daily activities dictate rain gear, shorts, T-shirts, warm clothes and water footwear will be needed. Sunglasses (polarized lenses are recommended) are also required for eye protection from an airborne hook and to see better through glare on the water. These stipulations are required for Camper's safety, sunburn and insect protection, comfort and health. Campers are asked to bring personal sunscreen and insect repellant.

• Day Camp Rules of Conduct are included in this Application Packet for parents/guardians to discuss in advance with their camper to ensure understanding before a youth applies and/or attends the opening session.

• In the unlikely event that a camper's behavior may become disruptive or unsafe, youth develops absenteeism or does not respond satisfactorily to counsel from volunteers or staff, the camper will be immediately removed from further participation and the parent-guardian will be contacted to come and remove the youth either temporarily or permanently from Day Camp activities. In such extraordinary instances the application fee may or may not be forfeited.

## **RULES OF CONDUCT**

# Campers are considered to be young adults and will be respected and treated accordingly. As such, there are some behaviors that they must responsibly observe.

- Campers may not leave the Day Camp unless authorized in advance by the Day Camp Director, and in some instances may be required to be accompanied by a designated camp staff volunteer.
- 2. All injuries are to be reported immediately to the Day Camp Director. No injuries are considered insignificant.
- 3. Campers are required to wear their name badges visibly around their neck at all times...and also wear appropriate clothing for the weather and the day's activity including rain gear and a hat with a brim.
- 4. Disruptive electronic devices are not permitted. Cell phones are permitted but during classes and activities only for use as a camera...not as a telephone for incoming or outgoing calls or texting without specific permission of the Camp Director. Calls during lunch or while on the vans are O.K.
- 5. Photographs are permitted only for taking pictures of camp recreational activities or surroundings, but not for scenes in which personal privacy can reasonably be expected by participants.
- 6. Physical or verbal abuse or social hazing; vulgar language, gestures or gender references; and displays of affection such as touching, or kissing are not acceptable camp behavior and are prohibited.
- 7. Lost & found articles are to be reported and turned in immediately to the Day Camp Director.
- 8. Parents/Guardians of a camper requiring revised medications must report this change immediately and in advance in writing to the Day Camp Director.
- 9. Camper will be paired with a fellow camper and an adult volunteer mentor during on-water activities. The Campers and the adult volunteer mentor must be mindful of camper buddy "in sight" limited participation and the time limits for each activity. **Stay on schedule!**

- 10. A camper or parent/guardian who drives a vehicle to camp may be required to relocate the vehicle to another location to accommodate the provided Day Camp activities transportation; if so, the camper or parent/guardian will be in the vehicle alone and will proceed directly to the designated new parking location following the camper van and with no stops enroute. Other unrelated campers who may have accompanied the camper or parent/guardian to camp that morning may be required to ride to the designated activities in the camper van transportation vehicle.
- 11. Campers who have attained age 16 are required to have a valid Colorado fishing license on their person when fishing or carrying a rod in or near the water.
- 12. Parent/guardians and campers are responsible to ensure the camper arrives on time each day, preferably a few minutes before 8:00 AM. This is important to ensure that sessions begin, and any scheduled activity transportation departs on schedule.
- 13. Use of tobacco products, illicit drugs or consumption of alcohol is strictly prohibited. No exceptions!
- 14. Violations of any of these rules may result in the camper being suspended from activities or immediate dismissal from camp. If a camper's behavior becomes disruptive or unsafe, and they do not respond satisfactorily to counsel from camp adult volunteer staff, the camper may be removed from further participation. If applicable, the parent/guardian will be contacted immediately, and the camper may be removed from Day Camp activities permanently.
- 15. Camp staff and volunteers are not responsible for a campers behavior, mental, or emotional conditions during Camp activities and will not act as a counselor or be *in loco parentis*. In cases of extreme distress a parent/guardian will be contacted and may need to be present as soon as possible.
